

The July 5, 2022 regular meeting of the Cogan House Board of Supervisors was called to order by Chairman Howard Fry with Supervisor Lori Douglass and Supervisor Daniel Roupp attending. There were approximately 21 residents attending. Pledge of Allegiance was given and after public comment. Janice L. stated that the ambulance service in Trout Run expressed that they are ready to give service to Cogan House Township and she feels that the Township should commit. Chairman Fry stated that he is not ready to commit until he has some records to review and look at their call list. He also stated that he has been trying to get in touch with the Fire Co in Trout Run and they still have not given the township the documents to look at. Chairman Fry assured it would be on the agenda for next month's meeting.

The Supervisors review the June 7, 2022 meeting minutes, the bill list and treasurer's report with no comment. Supervisor Douglass made a motion to accept and approve the reports with Supervisor Roupp seconded the motion, voted 3 – 0 MC.

There was not any Old Business to discuss.

Pavilion Rentals were for Barger for July 23, 2022.

New Business was the reopening of the 2022 budget to receive the Impact Fees from Act 13 in the amount of \$592,000.00 to be budgeted for the 2023 budget. During the conversation about the budget the recreation committee had talked about making a new stage for the band for the festival and if the township would assist in payment. Supervisor Roupp suggested that we give them their budget amount of \$2,000.00 and they would need to take care of the payment for the stage. Supervisor Roupp made a motion to donate their budget amount of \$2,000.00 with Supervisor Douglass seconded, voted 3 – 0 MC. Then Chairman Fry made a motion to accept the Act 13 monies into the budget for 2022 to be budgeted for the year 2023, Supervisor Roupp seconded, voted 3 – 0 MC.
